OAKMONT VILLAGE DECLARATION NO. 24 OF PROTECTIVE RESTRICTIONS

NOTICE IS HEREBY GIVEN that the Oakmont Village Declaration No. 24 of Protective Restrictions recorded on the 13th day of October, 1976, in book 3138 at pages 793 through 817 of the Official Records of the County of Sonoma, which restrictions are applicable to the Oakmont Subdivision situated upon the real property described in said Declaration No. 24 of Protective Restrictions, are hereby amended as follows;

- (1) Subsection (b) of Section 4 of Article VII shall be amended to read and provide as follows:

“(b) There shall be an annual meeting of the members of the Owners’ Association ~~between the 10<sup>th</sup> and the 17<sup>th</sup> day of January of each year at 9:30 a.m. prior to the 28<sup>th</sup> of February each year.~~ This change is made to assure the prior years final financial statements are available for the homeowners review and discussion. Said meeting to be held at the common area or at such other reasonable place as may be designated by written notice from the Board of Governors.”
