The property subject to said Declaration and this amendment is particularly described as follows:

All that certain real property situated in the City of Santa Rosa, County of Sonoma, State of California, as shown on maps entitled, "OAKMONT NO. 11-J" and recorded on the 21st day of November, 1978 in Book 280 of Maps, at Pages 8 and 9 in the Office of the Recorder of the County of Sonoma, State of California.

THE AMENDMENT

It is hereby certified by the undersigned that Article VII of the OAKMONT VILLAGE ASSOCIATION DECLARATION NO. 27 of Protective Restrictions is hereby amended to read as follows:

<u>Section 3 (a) Voting</u> At any meeting of the Owners Association, a member shall have the right to vote in person. Proxies will be recognized only for quorum and must be in writing. All proxies must be in writing and must designate the person or persons appointed to act as proxy.

Section 6 (a) Election of the Board of Governors

A Board of Governors shall be elected annually in accordance with Civil Code Section 1363.03, any amendments thereto, any other applicable law, and the rules adopted by the Board to implement Civil Code Section 1363.03.
